Dear players,

to make the application process as convenient as possible, we have created the following document which will provide you with all necessary information. Please read carefully through it to avoid complications.

A maximum of two non-Austrian teams in the main draw may be empowered to participate in each tournament. In exceptional cases, it is possible that the organizer will award its tournament Wild Card to a non-Austrian team

or

a maximum of four non-Austrian teams (consisting of a non-Austrian player and an Austrian player) may be empowered to participate in each tournament. In exceptional cases, it is possible that the organizer will award its tournament Wild Card to a non-Austrian team. These teams are seeded per tournament according to the national team points achieved together. Seeding in the qualifying tournament is possible.

There are no wild cards for the qualifying tournament for team wild cards possible.

There is a 4-step registration process:

1) The applying team has to send back the completed application form document via email to beachreferat@volleynet.at with all the gaps filled in:

Player Profile Player 1, Player Profile Player 2 and the name of the tournament **21 14 days prior** the respective tournament. You can find the player profile attached. If required: confirmation of participation from the national federation (please use the official FIVB form)

2) At this point all the necessary documents have to be available for the Austrian Volleyball Federation. Referring to the documents a committee of the Austrian Volleyball Federation will decide whether or not the team qualifies for the further qualification process.

3) ~~14 10~~ days prior the tournament you will receive a final confirmation / invitation that your team got accepted to participate in the tournament. This final confirmation of participation is binding for both parties. If you don't get this confirmation / invitation, you are not considered.

4) After confirmation the license fee of € 60,-- per Team (€ 30,-- per person) has to be transferred to our bank account until Tuesday before the respective tournament.

The registration deadline / entry deadline is 21 days prior to the tournament!

III. Competition System

- Main draw (Friday / Saturday / Sunday) for MASTERS
- Main draw (Saturday / Sunday) for OPEN
- Men & Women: Participation of 16 Teams (Participation of 12 or 8 Teams for OPEN-tournaments is possible)
- Modified Pool Play (4 Pools & Single Elimination) for MASTERS or Double Elimination System for OPEN-tournaments is possible.

IV. Seeding

Seeding following the FIVB World Tour entry ranking **only for team Wild Cards.**

FIVB Top 30 Teams => Position 1 or 2

FIVB Ranking 31-100 => will be drawn on position 3, 4 or 5

FIVB Ranking 101 - 200 => will be drawn on position 6, 7 or 8

FIVB Ranking ranked above 201 => will be drawn on auf Position 9 or 10

A downgrading in the ranking due to FIVB points and national points is not possible.

Teams consisting of a non-Austrian player and an Austrian player are seeded per tournament according to the national team points achieved together.
